IV. NON-CONSENT AGENDA ITEMS

- 1. To discuss and reconsider the use of existing Section 4(A) (Type A Economic Development Corporation) Sales and Use Tax within the City of Port Arthur shall be utilized for the cost of land, buildings, equipment, facilities, and improvements for the promotion of development and expansion of affordable housing, as described by 42. U.S.C. 12745 in a target area in Port Arthur, Texas, which is a category of projects under Section 505.153 of the Local Government Code (Type B Economic Development Corporation) related to the construction/development of single family dwellings and the total annual spending by the City of Port Arthur Section 4A Economic Development Corporation will not exceed \$300,000. A motion was made by Richard Wycoff and seconded by Harold Doucet to approve the above mentioned item with the specific boundaries of 8th Street to the South, 5th Street to the North, Atlanta Avenue to the West, and Nashville Avenue to the East. The vote was 5-2. Pat Holmes and Carol Wommack abstained from the vote. Motion passed.
- 2. To report, consider, and possible take action on providing a letter of support on the implementation of a municipal sales and use tax for the purposes of street maintenance and the reduction of the existing Section 4A (Type A Economic Development Corporation) Sales and Use Tax (1/2 percent) within the City of Port Arthur by 1/8 percent to be designated for street maintenance. The

remaining 3/8 percent will continue to be utilized for the Section 4A (Type A Economic Development Corporation) Sales and Use tax.

A motion was made by Harold Doucet and seconded by Carol Wommack to approve providing a Letter of Support to the City Council. The vote was unanimous. Motion carried.
