AN ORDINANCE AMENDING THE 2005/2006 BUDGET OF THE CITY OF PORT ARTHUR AS IT PERTAINS TO THE RECEIPT OF FUNDS FROM THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION FOR ADMINISTRATIVE REIBURSEMENT.

WHEREAS, on December 20, 2005, the City Council approved Resolution No. 05-376 authorizing the execution of an agreement between the City and the EDC for past and future administrative charges for the 2005-2006 fiscal year; and

WHEREAS, the agreement is for the City of Port Arthur Section 4A Economic Development Corporation to pay the City an Administrative charge in the amount of \$300,000, plus additional moneys of 4% of incentive agreements, as well as additional moneys for other services provided by the City; and

WHEREAS, the City can amend its budget for emergencies under Section 102.009, and for municipal purposes under Section 102.010 Local Government Code; and

WHEREAS, as denoted in Exhibit "A", the City will at this time receive \$96,310 for the second quarter of the fiscal year; and

WHEREAS, the City will receive two (2) more payments under this contract this fiscal year.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR, TEXAS:

- Section 1. That the facts and opinions in the preamble are true and correct.
- Section 2. That the 2005-2006 fiscal year budget of the City is herein amended as to designate all funds received pursuant to Resolution 05-316 to the West Side Development Project, for current and future related expenditures.
- Section 3. That a copy of the caption of this Ordinance be spread upon the minutes of the City Council.
