## RESOLUTION NO. 05-036

A RESOLUTION AUTHORIZING CHANGE ORDER 01 FOR THE CONTRACT DATED APRIL 26, 2005 BETWEEN THE CITY OF PORT ARTHUR AND DIKITA ENTERPRISES OF TEXAS, INC. FOR DESIGN OF THE WIDENING OF WEST 7<sup>TM</sup> STREET (REV. DR. RANSOM HOWARD STREET), EXTENDING THE TERM OF THE CONTRACT BY 60 DAYS AND INCREASING THE BUDGET FOR THIS ENGINEERING SERVICE BY \$24,200 TO A TOTAL OF \$72,070. CIP 004, 301-1601-591.86-00.

**WHEREAS,** on April 26, 2005 the City Council of Port Arthur executed a contract with Dikita Enterprises of Texas, Inc. for the design of the widening of West 7<sup>th</sup> Street (now Rev. Dr. Ransom Howard Street); and,

**WHEREAS**, Dikita has asked for an extension of 60 days and an increase to the budget of \$24,200; now, therefore,

THAT, the facts and opinions in the preamble are true and correct; and,

**THAT**, Change Order 01 (attached as Exhibit "A") extending the term of the contract to 220 days and increasing the budget for engineering design and construction phase services to a total of \$72,070 (CIP 004, 301-1601-591.86-00) is herein approved; and,

THAT, a copy of the caption of this Resolution be spread upon the Minutes of the City Council.
