A RESOLUTION APPROVING A PUBLIC BROADCAST AGREEMENT BETWEEN RADIO STATION KSAP-107.1 LPFM "THE BREEZE" AND THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION

WHEREAS, the City Council deems it in the public interest to authorize the City of Port Arthur Section 4A Economic Development Corporation to enter into an Public Broadcast agreement with Radio Station-107.1 LPFM "The Breeze"; and

WHEREAS, Port Arthur Economic Development Corporation will pay a sum of \$4,000 to The Breeze in advance for broadcasting 1,200 announcements during the 12 month period beginning November 15, 2007 through November 15, 2008; and

WHEREAS, no portion of the payment made by Port Arthur Economic

Development Corporation to The Breeze shall be used in any manner associated with
political announcement or the advertising of goods, services and products that are
contrary to directives from the Port Arthur Economic Development Corporation; and

WHEREAS, The Breeze shall provide notification to Port Arthur Economic

Development Corporation of the broadcast times by broadcast log on a basis no less than quarter annually during the term of this Agreement; and

WHEREAS, on October 17, 2007, the Port Arthur Section 4A Economic

Development Board approved a total expenditure of \$4,000 for public broadcast on The

Breeze radio station KSAP-107.1 to inform Port Arthur residents about the positive

economic impact that the Port Arthur Economic Development Corporation plays in the

City of Port Arthur; and

WHEREAS, the term of this Agreement shall only be renewed by action of the Board of Directors of the Port Arthur Economic Development Corporation and this Agreement does not renew automatically.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR:

Section 1. That the facts and opinions in the preamble are true and correct.

Section 2. That the City of Port Arthur Section 4A Economic Development Corporation is herein authorized to enter into Public Broadcast Agreement with Radio Station-107.1 LPFM "The Breeze" and the President and Secretary of the City of Port Arthur Section 4A Economic Development Corporation are authorized to sign the agreement in substantially the same form as denoted in Exhibit "A".

Section 3. That a copy of this Resolution shall be spread upon the Minutes of the City Council.
