

RESOLUTION NO. 10-031

**A RESOLUTION APPROVING A CONTRACT WITH MANNIX
MEDIA GRAPHIC DESIGN FOR IMPROVEMENTS,
ENHANCEMENTS, AND UPDATES TO THE WEB PAGE FOR
THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC
DEVELOPMENT CORPORATION**

WHEREAS, the City of Port Arthur Section 4A Economic Development Corporation (the "PAEDC") has developed a web page to promote the activities of the PAEDC, including its Spur 93 Business Park and to provide critical data for business prospects including economic profiles and links to local government and business resources; and

WHEREAS, the web page of the PAEDC has not been comprehensively enhanced or updated in approximately ten (10) years; and

WHEREAS, the Board of Directors of the PAEDC has determined that to maximize the economic benefits to be derived from its web page, PAEDC should obtain appropriate computer consulting and graphic design assistance to update and enhance the web page of the PAEDC to be more interactive and user friendly; and

WHEREAS, the PAEDC solicited proposals from local and regional computer and graphic designed businesses and interviewed prospective web design consulting firms; and

WHEREAS, after review of written materials and presentations, the Board of Directors has awarded a contract to Mannix Media Graphic Design of Orange, Texas in the amount of \$9,375.00, to update and rebuild its website to include information contained in the proposal from Mannix Media Graphic Design, attached hereto as **Exhibit "A"** and made apart hereof for all purposes (the "Proposal"); and

WHEREAS, the Corporation may in the future engage Mannix Media to provide the other additional services provided for in the Proposal.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR, TEXAS:

Section 1. That the facts and opinions in the preamble are true and correct.

Section 2. That the City Council of the City of Port Arthur concurs and approves the award of a contact to Mannix Media Graphic Design in accordance with the Proposal.

Section 3. That a copy of the caption of this Resolution be spread upon the Minutes of the City Council.




