

RESOLUTION NO. 11-314

**A RESOLUTION APPROVING AN AMENDMENT TO THE
PRICE FOR THE SERVICES BETWEEN THE CITY OF PORT
ARTHUR SECTION 4A ECONOMIC DEVELOPMENT
CORPORATION AND CHEVAL NOIR MEDIA OF PORT
ARTHUR FOR PRINTING AND MAIL-OUT OF A NEW SEMI-
ANNUAL NEWSLETTER**

WHEREAS, on May 31, 2011, at their regular meeting, the City Council of the City of Port Arthur approved Resolution No. 11-192 approving the City of Port Arthur Section 4A Economic Development Corporation (the "PAEDC") contracted with Cheval Noir Media of Port Arthur for printing and mail-out of a new semi-annual PAEDC Newsletter; and

WHEREAS, the price per printing and mail-out by Cheval Noir Media was quoted and approved by the Council as \$8,727.98; and

WHEREAS, the PAEDC in finalizing the newsletter has determined it necessary to add an additional page to the newsletter to accommodate the information and articles to be published and an information letter from Bob Phillips Productions as to the 2020 Vision Group; and

WHEREAS, it will require an upgrade to a larger 25.5 x 11" sheet of paper for an additional page in the newsletter; and

WHEREAS, the cost difference per printing and mail out services for the newsletter using the larger sheet of paper is an additional cost of \$1,921.68 as described in "Exhibit A"; and

WHEREAS, the PAEDC has originally budgeted sufficient funds for the additional cost of printing and mailing the newsletter.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE
CITY OF PORT ARTHUR, TEXAS:**

Section 1. That the facts and opinions in the preamble are true and correct.

Section 2. That the City Council of the City of Port Arthur hereby approves an amendment in the additional amount of \$1,921.68 per printing and mail out, to the contract with Cheval Noir Media for the printing and mail-out of a new semi-annual PAEDC Newsletter.

Section 3. That a copy of the caption be spread upon the minutes of the City Council.


