### RESOLUTION NO. 19-01

A RESOLUTION APPROVING THE DOWNTOWN RENAISSANCE DISTRICT AND THE PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION ENTERING INTO A PROMOTION AND DEVELOPMENT AGREEMENT AND APPROVING THE DOWNTOWN RENAISSANCE DISTRICT BUDGET FOR FY 2011-2012

WHEREAS, both the Downtown Renaissance District Board ("DRDB") and the Board of Directors of the Port Arthur Section 4A Economic Development Corporation ("PAEDC") have approved entering into a Promotion and Development Agreement in the amount of \$98,000 to be funded by the PAEDC for certain promotional services to be provided by the DRDB as outlined in "Exhibit A"; and

WHEREAS, the DRDB has also concurrently established a proposed budget for the 2011 – 2012 Fiscal Year attached hereto as "Exhibit B"; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR, TEXAS:

- Section 1. That the facts and opinions in the preamble are true and correct.
- Section 2. That the City Council of the City of Port Arthur approves the DRDB and the PAEDC entering into a Promotional Agreement for an amount of \$98,000 to be funded by the PAEDC to the DRDB for certain promotional services.
- Section 3. That the City Council also approves the DRDB proposed budget for FY 2011 2012.
- Section 4. That a copy of the caption of this Resolution be spread upon the Minutes of the City Council.

#### **RECITALS**

- A. District has been organized for the purpose of revitalization of Downtown Port Arthur by engaging the public, private, and non-private sectors in redevelopment projects.
- B. PAEDC through duly approved voter authorization has allocated certain 4A funds for the redevelopment and revitalization of designated areas within Downtown Port Arthur, Texas, referred to as the downtown revitalization target area (the "Target Area").
- C. PAEDC has developed regulations for use of the funds in the Target Area and has developed grant applications for public and private sector entities seeking to provide site improvements and infrastructure improvements in the Target Area under its Operation Downtown Grant Program.
- D. District and PAEDC acknowledge that their future collaboration will enhance the opportunities to promote revitalization of the Target Area.
- E. District has agreed to undertake certain promotion and development services on behalf of PAEDC in consideration of the District continuing to engage public, private, and non-profit sectors in redevelopment projects.
- F. District shall provide the services and shall request reimbursement through the City of Port Arthur, Texas (the "City") which manages the Promotion and Development Fund for PAEDC.

NOW, THEREFORE, the District and PAEDC agree as follows:

- 1. <u>DISTRICT AGREEMENTS</u>. The District shall undertake the following promotion and development services as consideration for the PAEDC commitments contained herein:
  - a) Maintain a database of contacts with downtown businesses and property owners as developed by District and/or PAEDC.

- b) Collaborate with PAEDC and act as a liaison to the downtown business community for the utilization of funds to assist in development and revitalization of the Target Area which is defined as that area of downtown Port Arthur lying between 9<sup>th</sup> Street, the Intercoastal Waterway, Houston Avenue and Lake Charles Avenue.
- c) Coordinate special events, art, and related cultural activities to promote public, private, and non-profit business entities utilization of the Target Area.
- d) Establish and maintain working relationships with public officials and the public to ensure information is disseminated on the Operation Downtown Grant Program.
- e) Assist PAEDC in securing and processing Operation Downtown Grant Program Applications to ensure qualification for funding.
- f) Monitor and coordinate Operation Downtown Grants for site and/or infrastructure projects after grants have been executed.

#### 2. PAEDC AGREEMENTS.

- (a) The District agrees to continue its mission of revitalization Downtown Port Arthur by engaging public, private, and non-profit sectors in redevelopment of projects and shall identify promotion and development opportunities to PAEDC to enable PAEDC to accomplish their promotion and development services as outlined in this Agreement.
- (b) District shall collaborate with PAEDC in the Operation Downtown Grant Program by assisting grant applicants in the presentation of appropriate applications for consideration by PAEDC and the City of Port Arthur for funding.
- 3. <u>PAEDC PROMOTION FUND</u>. PAEDC shall allocate in an amount not to exceed \$98,000 from its Promotion and Development Fund to (i) provide staffing necessary to meet any needs of the District hereunder as District does not maintain its own staff and will utilize PAEDC staff in certain administrative capacities; and (ii) reimburse or to pay on behalf of District approved expenditures during the term of this Agreement in the satisfaction of District Agreements in Paragraph 1 as set forth above.
