

RESOLUTION NO. 12-483

**A RESOLUTION AUTHORIZING THE PURCHASE OF A 2013 FORD F-150 REGULAR CAB TRUCK FOR THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION FROM PHILPOTT MOTORS OF NEDERLAND, TEXAS, IN THE AMOUNT OF \$16,348; FUNDING AVAILABLE IN ACCOUNT NO. 120-1429-582.92-00**

**WHEREAS**, during its regular meeting on September 6, 2012, the City of Port Arthur Section 4A Economic Development Corporation (the "PAEDC") Board of Directors approved the purchase of a new vehicle; and

**WHEREAS**, PAEDC's current vehicle, a 2003 Chevrolet Venture Van, has approximately 134,555 miles on it. PAEDC currently needs transportation that is conducive to hauling and towing, which the 2003 Chevrolet Venture is not.

**WHEREAS**, on October 2, 2012, the City Council of the City of Port Arthur approved amending the budget for the PAEDC for the fiscal year beginning October 1, 2012 and ending September 30, 2013 for the purchase of a 2013 Ford F-150 Regular Cab Truck per Ordinance No. 12-69; and

**WHEREAS**, the City of Port Arthur's Purchasing Department received four (4) quotes for the purchase of a new truck with the lowest quote from Philpott Motors ("Philpott") of Nederland, Texas, in the amount of \$16,348 for a 2013 Ford F-150 Regular Cab Truck as denoted in **Exhibit "A"**.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR, TEXAS:**

**Section 1.** That the facts and opinions in the preamble are true and correct.

**Section 2.** That the City Council authorizes the PAEDC to purchase a 2013 Ford F-150 Regular Cab Truck from Philpott Motors of Nederland, Texas, in the amount of \$16,348.
