

RESOLUTION NO. 14-467

A RESOLUTION AUTHORIZING THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION TO EXTEND THE CURRENT ON-THE-JOB TRAINING CONTRACT WITH BROCK SERVICES, LLC FOR REIMBURSEMENT OF FIFTY (50%) PERCENT OF TRAINING COSTS FOR PORT ARTHUR RESIDENTS THROUGH THE 2014-2015 FISCAL YEAR, IN THE NOT-TO-EXCEED AMOUNT OF \$24,049.50.

WHEREAS, on September 9, 2014, the City of Port Arthur Section 4A Economic Development Corporation ("PAEDC") Board of Directors approved extending the current On-the-Job Training Contract (the "Contract") with Brock Services, LLC ("Brock") through the 2014-2015 fiscal year; and

WHEREAS, the remaining balance on the contract is \$24,049.50 which has been allocated for training reimbursement per Resolution No. 13-520; and

WHEREAS, the extension will be in effect through the 2014-2015 fiscal year until the remaining balance of \$24,049.50 is exhausted; and

WHEREAS, trainees will be employed by Brock or one of its subcontractors on a full-time basis and will be trained to develop specific industrial skills which will enable them to be eligible for apprentice-level employment; and

WHEREAS, PAEDC will reimburse Brock fifty (50%) percent of the training hourly wages up to \$14.00 per hour after receiving proper documentation in an amount not to exceed \$24,049.50.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR, TEXAS:

Section 1. That the facts and opinions in the preamble are true and correct.

Section 2. That PAEDC is herein authorized to extend the On-the-Job Training Contract with Brock per Resolution No. 13-520 through the 2014-2015 fiscal year, in the not-to-exceed amount of \$24,049.50.

Section 3. That a copy of the caption of this Resolution be spread upon the Minutes of the City Council.

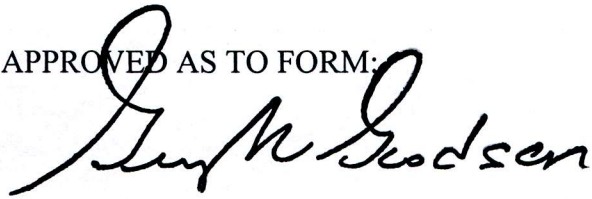

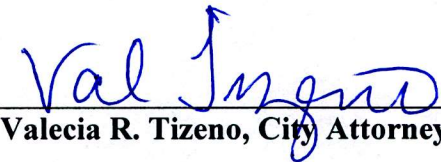
