## RESOLUTION NO. 14-615

A RESOLUTION AMENDING RESOLUTION NO. 14-326 BY CHANGING THE CONTRACT AMOUNT FROM \$476,717.95 TO \$482,767.95 FOR A CONTRACT BETWEEN THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION AND EXCAVATORS & CONSTRUCTORS, LTD. FOR WATER, SANITARY SEWER, PAVING AND DRAINAGE FACILITIES TO SERVE PROPOSED "KAPRINA FRANK DRIVE" IN THE SPUR 93 BUSINESS PARK

WHEREAS, on July 22<sup>nd,</sup> 2014, the City Council of the City of Port Arthur approved Resolution No. 14-326, a contract between the City of Port Arthur Section 4A Economic Development Corporation (the "PAEDC") and Excavators & Constructors, Ltd. in an amount not to exceed \$476,717.95; and

WHEREAS, the amount of the contract awarded to Excavators & Constructors, Ltd. should be \$482,767.95; and

WHEREAS, the City Council of the City of Port Arthur approves the correction to the contract between PAEDC and Excavators & Constructors, Ltd. in an amount not to exceed \$482,767.95.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR:

<u>Section 1</u>. That the facts and opinions in the preamble are true and correct.

Section 2. That the City Council of the City of Port Arthur approves the correction to Resolution 14-326 which incorrectly stated the contract between PAEDC and Excavators & Constructors, Ltd. was \$476,717.95 for road construction for the proposed "Kaprina Frank Drive".

<u>Section 3.</u> That the City Council authorizes PAEDC to execute a contract with Excavators & Constructors, Ltd. in an amount not to exceed \$482,767.95 for water, sanitary sewer, paving and drainage facilities to serve proposed Kaprina Frank Drive in the Spur 93 Business Park.

Section 4. That a copy of the caption of this Resolution be spread upon the Minute of the City Council.
