

### resolution no. <u>14-639</u>

A RESOLUTION AUTHORIZING THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION TO ENTER INTO A SECOND AND FINAL YEAR RENEWAL OF THE CONTRACT FOR LANDSCAPING AND IRRIGATION MAINTENANCE AT THE SPUR 93 BUSINESS PARK WITH AFFORDABLE LAWN & TRACTOR SERVICE OF PORT ARTHUR, TEXAS, IN AN AMOUNT NOT TO EXCEED \$28,500.00. EDC ACCOUNT NO. 120-1429-582.59-02

WHEREAS, per Resolution No. 12-399, the City Council of the City of Port Arthur (the "City Council") approved the City of Port Arthur Section 4A Economic Development Corporation (the "PAEDC") entering into a contract for landscaping and irrigation maintenance services with Affordable Lawn & Tractor Service ("Affordable") for PAEDC's Spur 93 Business Park; and

WHEREAS, the contractual agreement was the result of Affordable being awarded the contract through the bid process pursuant to §271.9051, Local Government Code as denoted in Exhibit "A"; and

**WHEREAS,** the contract was written with the option to renew for two (2) additional one (1) year periods; and

**WHEREAS**, per Resolution No. 14-001, the City Council approved the first renewal of the contract; and

WHEREAS, on December 1, 2014, the PAEDC Board of Directors approved the second and final year renewal of the contract with Affordable as denoted in Exhibit "B" to provide grass cutting, landscaping and irrigation maintenance in the amount of \$28,500.00 for the second and final year renewal.

### NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR, TEXAS:

Section 1. That the facts and opinions in the preamble are true and correct.

Section 2. That the PAEDC is herein authorized to enter into a second and final year renewal of the contract with Affordable for grass cutting, landscaping, and irrigation maintenance in the not-to-exceed amount of \$28,500.00 for the second and final year renewal as denoted in Exhibit "B".

Section 3. That a copy of the caption of this Resolution be spread upon the Minutes of the City Council.
