

RESOLUTION NO. 16-011

A RESOLUTION AUTHORIZING THE SECOND AND FINAL RENEWAL OF A CONTRACT FOR LANDSCAPING AND IRRIGATION MAINTENANCE AT THE SPUR 93 BUSINESS PARK BETWEEN THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION AND AFFORDABLE LAWN & TRACTOR SERVICES OF PORT ARTHUR, TEXAS, WITH A PROJECTED BUDGETARY IMPACT OF \$28,500.00; PAEDC ACCOUNT NO. 120-1429-582.59-02

WHEREAS, per Resolution 14-001, the City Council of the City of Port Arthur (the "City Council") approved the City of Port Arthur Section 4A Economic Development Corporation (the "PAEDC") entering into a contract for landscaping and irrigation maintenance services with Affordable Lawn & Tractor Services ("Affordable") for PAEDC's Spur 93 Business Park; and

WHEREAS, the contractual agreement was the result of Affordable being awarded the contract through the bid process pursuant to §271.9051, Local Government Code; and

WHEREAS, the contract was written with the option to renew for two (2) additional one (1) year periods; and

WHEREAS, on December 23, 2014, the City Council approved Resolution No. 14-639 that was written correcting an error stating that the resolution approved a second and final renewal to the contract, when in fact, it was and should have read as the first renewal of the original contract; and

WHEREAS, on December 7, 2015, the PAEDC Board of Directors approved the actual second and final renewal of the contract with Affordable to provide grass cutting, landscaping and irrigation maintenance in the amount of \$28,500.00 for one additional year.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF
PORT ARTHUR, TEXAS:

Section 1. That the facts and opinions in the preamble are true and correct.

Section 2. That the PAEDC is herein authorized to renew the contract with Affordable Lawn &
Tractor Services for grass cutting, landscaping, and irrigation maintenance in the amount of
\$28,500.00 for an additional and final one-year period.

Section 3. That a copy of the caption of this Resolution be spread upon the Minutes of the City
Council.

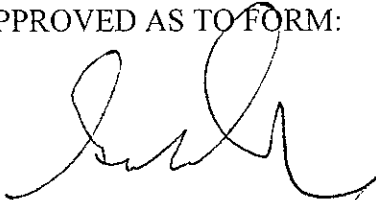
