A RESOLUTION APPROVING FUNDING OF \$7,500 FROM THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION TO SOUTHEAST **TEXAS ECONOMIC** DEVELOPMENT FOUNDATION (SETEDF) FOR THE THE REGIONAL **ECONOMIC** ASSISTANCE OF DEVELOPMENT INITIATIVE (REDI) **ECONOMIC** COORDINATE THE REGIONAL DEVELOPMENT EFFORTS FOR THE REGION OF HARDIN, JEFFERSON, AND ORANGE COUNTIES Account No. 120-1429-582.53-00

WHEREAS, the City of Port Arthur Section 4A Economic Development Corporation (the "PAEDC") deems it is in the public interest to seek the assistance of the Regional Economic Development Initiative ("REDI") to coordinate the regional economic development efforts for the region of Hardin, Jefferson, and Orange Counties.; and

WHEREAS, the REDI steering committee made up of local economic developers was formed by SETEDF to determine the services needed and to develop the structure of how these services could be provided for Southeast Texas; and

WHEREAS, the overall effort of the REDI is aimed at maximizing and retaining employment and increasing incomes; and

WHEREAS, PAEDC at its March 7, 2016, Board meeting voted to fund REDI in the amount of \$7,500; as denoted in Exhibit "A".

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR, TEXAS:

<u>Section 1</u>. That the facts and opinions in the preamble are true and correct.

Section 2. That PAEDC is herein authorized to assist in funding REDI in the amount of \$7,500 for one year.

Section 3. That a copy of the caption of this Ordinance be spread upon the Minutes of the City Council.
