

RESOLUTION NO. 18212

**A RESOLUTION APPROVING THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION ENTERING INTO A SERVICE AGREEMENT WITH KIRKSEY'S SPRINT PRINTING OF BEAUMONT, TEXAS FOR THE PRINTING AND MAILOUT OF THE 7<sup>th</sup> ANNUAL PAEDC NEWSLETTER; IN AN AMOUNT NOT TO EXCEED \$12,000 ACCOUNT NO. 120-1429-582.59-06**

**WHEREAS**, on May 7, 2018, at their regular Board meeting, the City of Port Arthur Section 4A Economic Development Corporation ("PAEDC") Board of Directors approved a quote awarding Kirksey's Sprint Printing for the printing and mailout services for the PAEDC 7<sup>th</sup> annual summer newsletter (the "Newsletter"); and

**WHEREAS**, the Newsletter will be printed and mailed out in the summer as a vital communication resource to inform local citizens on the economic development efforts and accomplishments of PAEDC and its partners; and

**WHEREAS**, request for quotes were sent to seven companies and of the seven companies, four submitted quotes for the printing and mailout services of the Newsletter (see **Exhibit "A"**); and

**WHEREAS**, on May 7, 2018, at its regular Board meeting, the PAEDC Board of Directors approved the printing and mailout services for the Newsletter utilizing the services of Kirksey's Sprint Printing in an amount not to exceed \$12,000.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR, TEXAS:**

**Section 1.** That the facts and opinions in the preamble are true and correct.

**Section 2.** That PAEDC is hereby authorized to enter into a contract with Kirksey's Sprint Printing for the printing and mailout of the Newsletter at a cost not to exceed \$12,000.


**Section 3.** That a copy of the caption be spread upon the minutes of the City Council.




