## RESOLUTION NO. <u>19-165</u>

A RESOLUTION APPROVING THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION TO ACCEPT A PROPOSAL FROM CONSTRUCTION MANAGERS OF SOUTHEAST TEXAS, LLC FOR TEMPORARY LIGHTING AT 549 4<sup>TH</sup> STREET FOR A COST NOT TO EXCEED \$13,829.88; FUNDS AVAILABLE IN EDC ACCOUNT NO. 305-1606-591.82-00, PROJECT NO. EDC549

WHEREAS, the PAEDC recommends acceptance of the proposal submitted by Construction Managers of Southeast Texas, LLC for temporary lighting in the building at 549 4th St. for an amount not to exceed \$13,829.88 as detailed in Exhibit "B".

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR:
