A RESOLUTION APPROVING THE CLOSING OF THE ECONOMIC DEVELOPMENT CONDITIONAL GRANT AGREEMENT BETWEEN THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION AND JOE'S SHOPPING PLAZA, LLC

It is recommended that the Board close the Economic Development Conditional Grant Agreement with Joe's Shopping Plaza, LLC ("Joe's Plaza") as Joe's Plaza has fully satisfied the terms of the Agreement with the PAEDC.
