

RESOLUTION NO. 19-407

**A RESOLUTION APPROVING THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION ENTERING INTO A SERVICE AGREEMENT WITH KIRKSEY'S SPRINT PRINTING OF BEAUMONT FOR THE PRINTING AND MAILOUT OF THE 8<sup>th</sup> ANNUAL PAEDC NEWSLETTER IN AN AMOUNT NOT TO EXCEED \$17,000. **WHEREAS**, on September 9, 2019, at their Special Board meeting, the City of Port Arthur Section 4A Economic Development Corporation (the "PAEDC") Board of Directors approved a quote awarding Kirksey's Sprint Printing for the printing and mail out services for the 8<sup>th</sup> Annual Newsletter; and

**WHEREAS**, the Newsletter will be printed and mailed out in the summer as a vital communication resource to inform local citizens on the economic development efforts and accomplishments of PAEDC and its partners; and

**WHEREAS**, Request for Quotes were sent to seven (7) companies, and of the seven (7) companies four (4) submitted for the printing and mail out services of the 8<sup>th</sup> Annual PAEDC Newsletter, whereas the top (3) that were cost efficient were chosen and a bid tabulation completed (see **Exhibit "A"**); and

**WHEREAS**, on September 9, 2019, at its Special Board meeting, the PAEDC Board of Directors approved the printing and mail out services for a 8<sup>th</sup> Annual PAEDC Newsletter utilizing the services of Kirksey's Sprint Printing; the amount should not exceed \$17,000.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR, TEXAS:**

**Section 1.** That the facts and opinions in the preamble are true and correct.


