WHEREAS, the City Council deems it is in the public interest to authorize the City of Port Arthur Section 4A Economic Development Corporation ("PAEDC") to retrofit the property located at 549 4th Street in downtown Port Arthur (the "Press Building"); and

WHEREAS, per Resolution No. 21-027, the City Council approved PAEDC was authorized to enter into a lease purchase agreement with DataVox for data network equipment for the Press Building; and

WHEREAS, there was found to be a need for additional electrical conduit, cores, sleeves, back boxes, floor boxes, power poles, NEMA Enclosures, pull boxes and pull string; and

WHEREAS, DataVox has subcontracted with Jefferson Electric to perform such work as they are the current electrical contractor on the project; and

WHEREAS, the PAEDC Board of Directors approved this additional expense at their Board meeting on April 5, 2021; and

WHEREAS, this additional equipment is deemed necessary to complete the electrical portion of the project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR:

Section 1. That the facts and opinions in the preamble are true and correct.

Section 2. That the City Council approves the additional expense of \$28,748.00 payable to DataVox as described in the document attached hereto as Exhibit "A" for the additional electrical components necessary to complete the Press Building.

Section 3. That a copy of the caption of this Resolution be spread upon the Minutes of the City Council.
