A RESOLUTION AUTHORIZING THE WAIVER OF BUILDING PERMIT FEES IN THE NOT TO EXCEED AMOUNT OF \$11,484.00 ASSOCIATED WITH PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION PHASE 2 RECONSTRUCTION OF THE PRESS BUILDING LOCATED AT 549 4TH STREET, PORT ARTHUR, JEFFERSON COUNTY, TEXAS
