RESOLUTION NO. 21-410

A RESOLUTION APPROVING AN INVOICE PAYMENT IN THE AMOUNT OF \$5,005.00 FROM JOEY'S TRACTOR SERVICE TO THE PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION FOR LAWN SERVICE AT THE EDC BUSINESS PARK; FUNDS AVAILABLE IN ACCOUNT NO. 120-80-625-5479-00-00-000; AND SETTING AN EFFECTIVE DATE.

WHEREAS, the City Council deems it is in the public's interest to authorize the City of Port Arthur Section 4A Economic Development Corporation (the "PAEDC") to pay Invoice No. 2887 to Joey's Tractor Service; and
