

RESOLUTION NO. 22-193

A RESOLUTION AUTHORIZING THE PURCHASE OF EXTERIOR SIGNAGE FOR THE LAMAR STATE COLLEGE CULINARY ARTS ENTRANCE OF THE PRESS BUILDING FROM SIGN INTERNATIONAL IN THE AMOUNT OF \$5,745.00. FUNDS AVAILABLE IN EDC ACCOUNT NUMBER 120-80-625-5494-00-000.

WHEREAS, the City of Port Arthur Section 4A Economic Development Corporation entered into a five-year lease with Lamar State College Port Arthur at The Press Building located at 549 4th Street; and

WHEREAS, the City of Port Arthur Section 4A Economic Development Corporation has agreed to purchase the exterior signage for the Press Building; and

WHEREAS, Sign International, the sign contractor for the rehabilitation and renovation of The Press Building has provided a quote for the signage in the amount of \$5,745.00 as attached hereto as Exhibit "A"; and

WHEREAS, the City of Port Arthur Section 4A Economic Development Corporation, the architect/design team and Lamar State College Port Arthur have approved the design of the signage; and

WHEREAS, the City of Port Arthur Section 4A Economic Development Corporation Board of Directors approved this purchase at its regular board meeting on April 4, 2022.


