A RESOLUTION AUTHORIZING THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION TO ENTER INTO A CONTRACT FOR THE TRACTOR MOWING SERVICES OF THE HIGHWAY 73, JADE AVENUE AND SPUR 93 BUSINESS PARKS WITH B&N MOWERS, LLC OF PORT ARTHUR, TEXAS, IN THE AMOUNT NOT TO EXCEED \$38,000.00. PAEDC FUNDING ACCOUNT NO. 120-80-625-5479-00-00-000

WHEREAS, The City of Port Arthur Section 4A Economic Development Corporation ("PAEDC") owns the properties known as the Highway 73, Jade Avenue and Spur 93 Business Parks and is obligated to maintain these properties; and

WHEREAS, the PAEDC advertised a Request for Proposal (RFP) for tractor mowing services at the Highway 73, Jade Avenue and Spur 93 Business Parks; and

WHEREAS, a PAEDC representative reviewed all quotes submitted for this project; quotes were submitted by Howell's Bushhogging at \$98 per acre and B&N Mowers, LLC at \$30 per acre, and

WHEREAS, at their July 10, 2023, Regular Board Meeting the PAEDC Board of Directors approved the quote for the tractor mowing services of the Highway 73, Jade Avenue and Spur 93 Business Parks submitted by B&N Mowers, LLC. The PAEDC recommends awarding the contract, *Exhibit "A"*, for the tractor mowing services to B&N Mowers, LLC based on a cost of \$30.00 per acres, and an amount not to exceed \$38,000 for a period of 1 year, with an option to renew for two additional 1-year periods.

## NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR, TEXAS:

Section 1. That the facts and opinions in the preamble are true and correct.

Section 2. That the City Council of the City of Port Arthur approves the award of the quote and authorizes execution of a contract between PAEDC and B&N Mowers, LLC for Tractor Mowing Services of the Highway 73, Jade Avenue and Spur 93 Business Parks in the amount not to exceed \$38,000 for a period of 1 year, with an option to renew for two additional 1-year periods.
