

RESOLUTION NO. 24-133

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PORT ARTHUR RATIFYING THE CITY OF PORT ARTHUR SECTION 4A ECONOMIC DEVELOPMENT CORPORATION'S ENGAGEMENT OF INDUSTRIAL AND COMMERCIAL MAINTENANCE (ICM) OF BEAUMONT, TEXAS TO FURNISH AND INSTALL TWO (2) NEW HVAC CONDENSING COILS AT 549 4TH STREET, AT A COST NOT TO EXCEED \$17,922.85, FUNDS AVAILABLE 120-80-625-5318-00-00-000

WHEREAS, The Port Arthur Section 4A Economic Development Corporation ("PAEDC") owns the property located at 549 4th Street and is obligated to maintain this property;
and

WHEREAS, Industrial and Commercial Maintenance (ICM) is the vendor the PAEDC is contracted with to oversee the Preventative Maintenance for the HVAC system at 549 4th Street;
and

WHEREAS, On February 29, 2024, the system that services the second floor of the premises stopped cooling and ICM was called out to investigate/repair. Upon examination, it was discovered the two (2) condensing coils were leaking and are no longer working properly and in need of replacement; and

WHEREAS, the area of the building impacted encompasses the Flex Room, which is utilized on a frequent basis for various workshops, training, etc.; and

WHEREAS, PAEDC deemed the need for emergency repairs for the public health, safety and welfare associated with occupancy of the building, **Exhibit "A"**; and

WHEREAS, ICM, an awarded vendor for Buyboard Contract #638-21, provided a proposal for the necessary repair, **Exhibit "B"** in the amount of \$17,922.85; and

WHEREAS, ICM has received the approved proposal and will begin the repair upon receipt of the necessary parts; and

WHEREAS, the PAEDC Board of Directors at their March 14, 2024 Board Meeting, has ratified the emergency engagement of Industrial and Commercial Maintenance in the same form as the Proposal attached hereto as Exhibit "B".

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ARTHUR:

Section 1. That the facts and opinions in the preamble are true and correct.

Section 2. That the City Council hereby ratifies the City of Port Arthur Section 4A Economic Development Corporation to engage ICM to furnish and install 2 new condensing coils at 549 4th Street at a cost of \$17,922.85.

Section 3. That a copy of the caption of this Resolution be spread upon the Minutes of the City Council.




